- Minimum 3 year tertiary qualification in social work, behavioural science, psychology, or a related field is essential.
- Minimum of three years' experience in the provision of family violence or other social support services, including experience leading a team in a social services setting.
- Experience in delivering social services in related fields including mental health, alcohol and other drug use, child protection, or disability highly regarded.
- Experienced at undertaking comprehensive risks and needs assessments and risk management responses as well as leading same within a team of specialist practitioners.
- Experience in providing reflective practice/clinical supervision to a team of specialist practitioners responding to family violence or other related social services setting.
- Understanding of contemporary family violence and trauma informed theory and practice frameworks pertinent to supporting women and children to be psychologically and physically safe and resilient from harm perpetrated.
- Understanding of contemporary gender issues and social justice principles pertinent to women's and children's health and wellbeing.
- An understanding of intersectionality as it relates to diverse and marginalised populations, as well as, experience and commitment to working with same that is responsive and sensitive to their diverse contexts, cultures and marginalisation.
